Quincy Recreation Swimming Lessons 2019

Celebrating Our 44th Year of the Learn to Swim Program at the Lincoln Hancock Pool!

The Quincy Recreation Department will conduct swimming instruction for Quincy residents age six and above at the Lincoln Hancock Community School Pool, during July and August. Water Safety Instructors and lifeguards trained in accordance with standards set by the American Red Cross will teach the lessons.

Testing for swimmers unsure of which class to register for will be held on **Friday**, **June 7**, **2019 from 6:30 to 8:30 p.m.** Testing is for swimmers unfamiliar with the swim program or who have had instruction during the winter. Non-swimmers who have never taken lessons do not need to be tested and should register for Level I/II. The **Boating and Sailing prerequisite swim test** will also be given at this time for residents age 8 or older.

There will be three sessions of swim instruction. Participants may register for one session only. Session 1 begins Monday, June 24, 2019 and ends Tuesday, July 16, 2019. Session 2 begins Thursday, July 18, 2019 and ends Thursday, August 8, 2019. Session 3 will run on Monday and Thursday evenings beginning on Monday, June 24, 2019 and ending on Thursday, August 8, 2019.
